- 1. This is to inform that the UGC has issued Revised Guidelines Vide D.O.No.F.1-1/2020 (Secy) dated 06.07.2020 and Standard Operating Procedure (SOP) of MHRD dated 08.07.2020 regarding Examinations and Academic Calendar for the Universities in view of COVID-19 Pandemic situation for conduct of Examinations vide references 1st and 2nd respectively.
- 2. The same has also been communicated to our University through a memo by the Higher Education (MC) Department, Telangana vide reference 4th.

Therefore, our University also resolved to adopt the guidelines on "Provision of Examination through Special Chance" of the memo of the Higher Education (MC) Department, Telangana, issued vide reference 4th for conducting Final Year UG and PG Final Semester/Year Examinations of the AY19-20 as a one-time measure.

The "Provision of Examination through Special Chance" has been communicated at para 3 of the circular.

3. Provision of Examination through Special Chance:

In case a student of terminal semester/ final year is unable to appear in the examination conducted by the University for whatsoever the reason(s) may be, he/she may be given opportunity to appear in special examinations for such course(s)/ paper(s), which may be conducted by the university as and when feasible, so that the student is not put to any inconvenience/ disadvantage. The above provision shall be applicable only for the Semester-2 of Academic Year 2019-20 as a one-time measure.
