

This is to inform all students that it is mandatory to clear any outstanding fee dues **on or before 5<sup>th</sup> September 2024**. Failure to settle these dues by the stipulated date will result in the suspension of their registration for the semester – I of academic year 2024-25.

In accordance with the university's regulations, all students are required to clear their fee payments on a regular basis. In view of huge backlog of fee dues, University has been repeatedly issuing the circular from time to time to clear the pending fee dues. Previous notices regarding this matter have been cited for reference, emphasizing to clear the fee dues failing which students will not be permitted to write the exams. *However, most of the students have requested to permit them to write the exams and ensured that they would clear the dues before the commencement of the new academic year 2024-25.*

As per Circular dated 13.11.2017, the semester registration of the students who fail to clear their fee dues was not permitted. The adherence to these regulations is crucial for the smooth continuation of the academic and administrative processes.

Therefore, all students are requested to take immediate action to resolve any pending fee issues.
