Clarification of criteria:

- The courses should have been completed in the first attempt. First attempt implies that the candidate should clear the final year/semester examination (including Xth, XIIth, Diploma, Graduation and Post-Graduation as applicable) with minimum aggregate (aggregate of all subjects in all semesters) marks of 60% and above within the stipulated duration of the course itself. For example, if a candidate has secured 58.9 % (aggregate of all subjects) in Standard XIIth examination in the first attempt, and has taken an improvement exam in the next attempt securing 62 %, he/she does not fulfil the TCSL eligibility criteria as marks/CGPA obtained during the normal duration of the course only will be considered.
