**Subject: Academic Section - End Semester Examinations (ESEs) (Remedial) for Academic Year 2019-20, Semester-II - Reg.**

This is to inform that the End Semester Examinations (ESEs) (Remedial), AY19-20, Semester-II, will be conducted in the University Campus in offline mode from 20/08/2021.

The evaluation pattern shall be as same as the ESEs (Regular) of AY19-20, Semester-II, which is as follows.

- The duration of the exam shall be 2 hours.
- Each question paper of the ESE is for 60 marks and shall consist of objective type questions for 30 marks and another 30 marks for descriptive type questions.
- In the descriptive section - 3 questions are to be answered out of 6 and each question carries 10 marks.
- The objective type section shall consist of multiple-choice questions (MCQs); fill in the blanks and short answer type questions. The number of questions may vary from 15 to 30 and so as the weightage; each question can be given for one (01) mark or two (02) marks.

The Controller of Examinations (CoE) is requested to take all other regular necessary actions of examination procedures to see that the exams are conducted smoothly.
