1. This is to inform that in view of the COVID-19 pandemic and subsequent lockdown, the University Grants Commission (UGC) constituted an Expert Committee to deliberate and make recommendations on the issues related to the Examinations and the Academic Calendar for avoiding loss and taking appropriate measures in the interest of students.


Based on the recommendations of the Expert Committee, the UGC has developed “Guidelines on Examinations and Academic Calendar for Universities in View of COVID-19 Pandemic and Subsequent Lockdown” vide reference 1st cited.

2. One of the guidelines issued by the Commission (at para 11 and 12 of reference 1st) that the Universities may conduct practical examinations and Viva-Voce Examinations online through Video Conferencing using Google, Skype, Microsoft Technologies or any other reliable and mutually convenient technology, subject to the approval of the concerned statutory authority of the university.

On the same lines, as guided by the Commission, it has been approved by the Vice-Chancellor, vide reference 2nd, that the Project Viva-Voce, Comprehensive Viva, Internships, Seminars and Assignments of the Semester – II of AY19-20 of our university shall be evaluated through online mode also (wherever it is possible).


For other students, who do not have internet access, the evaluation of the Project Viva-Voce, Comprehensive Viva, Internships, Seminars and Assignments shall be done through offline mode i.e., through any other alternative means available.

Therefore, the Heads of the Departments (HoDs) concerned shall take all necessary actions for evaluation of the Project Viva-Voce, Comprehensive Viva, Internships, Seminars and Assignments, of Semester – II of AY19-20, through whichever means available and the same may be sent to the Examination Section as and when the evaluation is done.
