In this regard, the following guidelines are being issued to all the heads of administrative sections, teaching / non-teaching staff and to the students to maintain proper hygienic conditions in view of the COVID-19 pandemic as it is still prevalent.

1. As all the students are called to the campus, the academic blocks, departmental buildings, hostels, messes and the entire premises shall be made ready for starting on-campus class work.
2. COVID-19 precautionary measures shall be taken at the students' hostels, messes and wherever the students are expected to be gathering.
3. The concerned authorities of the University shall see that proper hygienic conditions are being maintained at academic blocks,

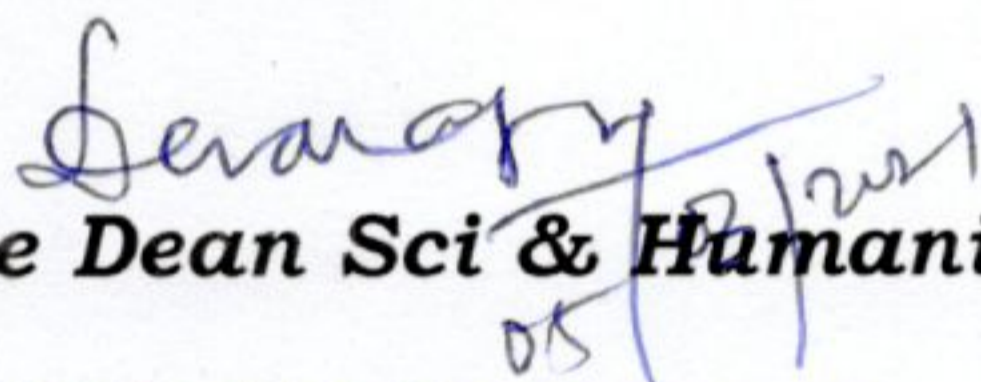
laboratories, hostels, messes, toilets etc with frequent sanitization.

4. The students and parents shall submit undertaking forms that they will follow the COVID-19 precautionary norms strictly in the University premises and hostels.

The undertaking forms (annexed at the end of this circular) to be submitted by the students and parents have been enclosed to this circular at the end. The undertaking forms shall be submitted to the security personnel at the main gate.)

5. It is suggested that the students may come with a latest COVID-19 test report.
6. All the teaching / non-teaching staff and students shall wear masks and use sanitizer of their own.
7. The Student Welfare Section / the Chief Warden / the RMOs (hospital) / the HoDs / the Security Officials and any other statutory officials of the University may issue necessary guidelines / instructions from time to time to the staff / students.
