<u>CIRCULAR</u> (For E1 Students)

As per the Academic Rules and Regulations that are in force w.e.f AY16-17, it is to inform that the following E1 students having less than 65% of attendance are not permitted for End Semester Examinations (ESE), both labs and theory, that have been scheduled for Semester – I of AY19-20.

However, the students having attendance from 65% and below 75% are, conditionally, being permitted for ESE, both labs and theory subject to the condition that their candidature for ESE will only be examined upon receiving valid medical documents from the students.

Rules for Students Having Attendance Less Than 65%

Students having attendance less than 65%, stand to lose all credits and marks acquired during the current academic year i.e., 2019 – 20. This is applicable also for the End Semester Lab Examinations for which the students have been conditionally allowed to appear. The students whoever are found to be under 65% category are declared as detained in the same year of study.

Rules for Students Having Attendance from 65% and below 75%

The students who have attendance from 65% and below 75% and who request that their attendance be condoned on health grounds (upto 10% condonation is allowed as per rules) should produce their medical certificates viz., prescriptions and medical certificate, to the Academic Section by 12:00 Noon on 09/12/2019.

It may be noted that the submission of documents does not guarantee that the attendance will be condoned.

The certificates submitted by the students will be examined by the University and the students whose cases are found genuine and authentic will only be permitted to appear for ESE upon payment of Rs. 500/- as condonation fee as per the existing Academic rules and regulations.

Students who fail to produce the essential medical documents on or before 09/12/2019 by 12:00 Noon will be treated as defaulters and their candidature for ESE will not be considered further under any circumstances.
