The role and position is for Trainee Software Engineer to be converted as Associate Software Engineer after confirmation. The role would be either a <u>mobile stack developer</u> or a <u>web-cloud stack developer</u>. The role would involve product development engineering and we expect candidate to think several notches superior than a back-end job in a large organization.

1. Trainee Software Engineer (Applicable for the duration of training 12-months)

An <u>average</u> monthly stipend of Rs.11, 000 would be paid during the period of internship training of 12 months, net of all

The stipend payable would be Rs.8,000 per month for Stage-I and would go on to be Rs.14,000 per month in Stage-IV. This stipend would be exclusive of other benefits mentioned in item#4 listed below. down by 3 months based on progress. It should be noted that there is a commitment bond of 30 months including the training period (18 months excluding the training period).
